Firstly, thank you. Not only does it significantly help our patients, it is also deeply encouraging to our clinical services team to know that you are giving them such support.

There are various ways that you can leave a gift in your will to Franklin Hospice:

1. A residuary gift such as part of your estate.
2. A percentage gift such as a *percentage* of your estate.
3. Or a specific gift, whether that be money, property or belongings.
4. By adding a codicil to an existing Will. (Please see over for an example of the wording of a Codicil in favour of Franklin hospice).

Whichever way you choose to structure your bequest to Franklin hospice, we strongly recommend that you contact your solicitor to ensure all aspects of your will are current.

Codicil

If you already have a will, you are able to make a simple modification to it by adding a codicil, such as this example below. Please feel free to use it if that option works for you.

**"I give to Franklin Hospice, registered charity number CC22373, the sum of \$.....
(or)% of my estate (or) of the residue of my estate (or) property or assets as follows:**

.....
.....
.....

for the general purposes of Franklin Hospice and the receipt of Franklin Hospice shall be full and sufficient discharge to my trustees."

Then its just a matter of contacting your solicitor to add this codicil to your existing Will. We strongly recommend that you contact your solicitor to ensure all aspects of your Will are current.

Finally, please let us know if you have left Franklin hospice a gift in your Will because it significantly helps us to be more confident in our planning for the future.

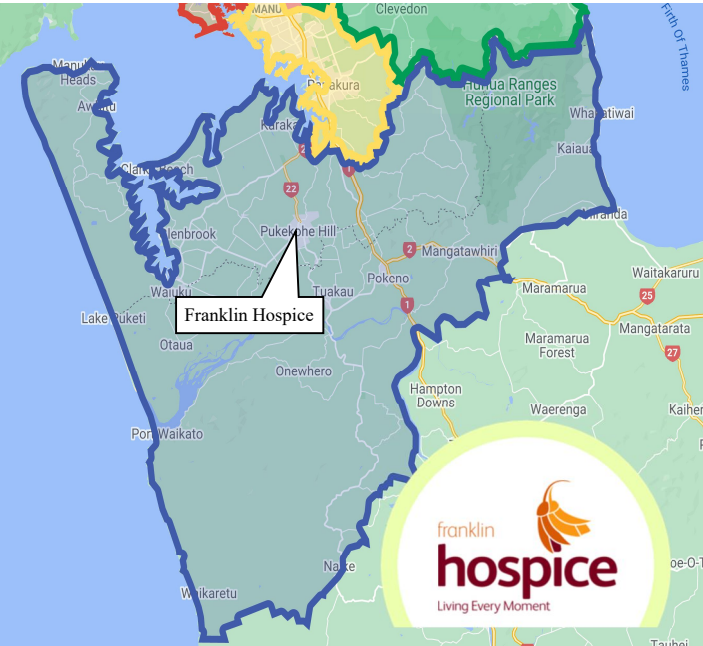
